***Kelly Powers*** has been involved with the Peruvian Paso breed for 25 years. Her great-uncle, George Stevenson had the first two Peruvian horses in the United States in the 1920's ~ two buckskin stallions named Norbo & Gringo. She started showing at age 7 and was a very successful junior rider. She has shown horses all over the U.S. and has competed at the National Show in Peru several times, as well as National shows in Guatemala, Honduras and El Salvador. As a successful Amateur competitor, Kelly has hundreds of Regional Championships to her credit and started winning National Championship titles at the age of 13. Kelly owns Phenom Farms, home to MCD Coronado+ in Buellton California ([www.phenomfarms.com](http://www.phenomfarms.com)) where she has a small but focused breeding program. ### SOME THINGS YOU NEED TO KNOW

- Please plan on arriving at Ringstead Ranch on Friday August 19<sup>th</sup> between 5 and 6 PM. Directions are attached.
- Inside box stalls are available for the weekend and include feed buckets and automatic waterers.
- Please ensure you bring enough feed for your horse to last the duration of the clinic. Feed will not be provided.
- Please bring all your own tack. Tack will not be provided or lent out. **RIDING HELMETS ARE MANDATORY!**
- Please notify us ASAP if you do not have a horse and require a "loaner". We will do our best to accommodate your needs.
- Clinic will be held in either inside or outside riding arenas, depending on weather conditions.
- Safe and secure accommodations with full kitchen and bathroom are provided on site for all participants. Please bring a foamie, sleeping bag, pillow, towels and all other personal items. Overnight supervision is provided.
- Please plan on staying until approximately 5 PM on Sunday.

TO: RINGSTEAD RANCH LTD and their Directors, Shareholders, Owners, Officers, Operators, Employees, Staff and Agents.

In consideration of Ringstead Ranch Ltd. accepting my application on behalf of myself and any minor child on whose behalf I sign this Agreement, for participation in any activity or service operated or organized by Ringstead Ranch Ltd. I agree to this release of claims, waiver of liability, assumption of risk and indemnity agreement (collectively "this Agreement).

I declare that in participating, or in permitting the participation of any minor child in respect of whom I sign this Agreement (the "child") in any activity or service operated or organized by Ringstead Ranch Ltd., I waive any claims that I may have against Ringstead Ranch Ltd. and release Ringstead Ranch Ltd. from all liability for injury, death, damage or loss (financial, economic, to property or otherwise) sustained by me as a result of my participation or the participation of the Child in such activity due any causes whatsoever including, without limitation, negligence on the part of Ringstead Ranch Ltd.

I further agree to indemnify Ringstead Ranch Ltd. against any liability resulting from such participation to any third party or any persons in respect of whom I sign this Agreement (the Child or other).

I acknowledge that activities may be outdoors and may involve risks and dangers associated with the use of horses which regardless of their training and passive behavior may act or react unpredictably at times because of instruction or fright. **THERE IS A RISK FACTOR IN THESE ACTIVITIES** which cannot be lessened by Ringstead Ranch Ltd. I further agree to promptly pay any claim or damage to the equipment and horses provided by Ringstead Ranch Ltd. caused by me or the Child and I will return all equipment and horses in as good a condition as when I received them, reasonable wear and tear excepted.

I agree to adhere to the safety and other rules stipulated by Ringstead Ranch Ltd. if any, and I agree to any costs incurred by Ringstead Ranch Ltd. if I am in breach of any such rules.

I understand outdoor activities involve additional risks and dangers, some of which include weather, which can be extreme and can change rapidly without warning; remote locations in natural and mountainous terrain, where natural hazards abound, and where participants may become lost or separated from their guide, where rescue and communication can be difficult and where medical treatment may be unavailable.

I agree to allow Ringstead Ranch Ltd. to seek out medical aid on my behalf if I or the Child is involved in an accident.

I fully understand the risks and dangers involved in these activities and I do hereby acknowledge and accept same entirely at my/our own risk.
